

PRIVACY POLICY – RESTORE THE LEGACY

1. Introduction

Restore the Legacy (“we,” “us,” “our”) is committed to protecting your privacy and handling personal data responsibly. This Privacy Policy explains how we collect, use, store, and protect your personal data in compliance with Dutch and European law (GDPR).

By engaging with Restore the Legacy, you agree to the collection and processing of your personal data as described below.

2. Data We Collect

We collect and process personal data when you:

- Make a donation.
- Register for an event or purchase a ticket.
- Subscribe to our newsletter.
- Contact us via email or our website.
- Engage with us on social media.

The personal data we may collect includes:

- Personal Information: Name, email address, phone number.
- Financial Information: Payment details for donations or event registrations.
- Technical Information: IP address, browser type, and website usage (via cookies).

3. Purpose of Data Processing

We use personal data to:

- Process donations and issue receipts.
- Manage event registrations and participation.
- Send updates, newsletters, and relevant communications (only if consented to).
- Improve our website and services through analytics.
- Comply with legal and regulatory obligations.

We never sell or share personal data for commercial purposes.

4. Legal Basis for Processing

Restore the Legacy processes personal data based on:

- Consent: When you subscribe to our newsletter or provide information voluntarily.
- Contractual Necessity: When you donate or register for an event.
- Legal Obligation: To comply with Dutch and EU regulations.
- Legitimate Interest: To engage with our supporters and improve our services.

5. Data Storage & Security

- We take strict technical and organizational measures to protect personal data against unauthorized access, loss, or misuse.
- Data is stored on secure servers within the European Union.



- Personal data is only retained for as long as necessary for the purposes outlined in this policy.

6. Your Rights Under GDPR

As a data subject, you have the right to:

- Access your personal data.
- Request corrections to inaccurate or incomplete data.
- Request deletion of your data (“right to be forgotten”).
- Withdraw consent for marketing communications at any time.
- Restrict processing of your data under certain conditions.
- Request data portability to another service provider.

7. Data Sharing & Third Parties

We may share personal data with:

- Service providers (e.g., payment processors, email services) only when necessary for our operations.
- Legal authorities if required by law.

All third parties must comply with strict data protection regulations.

- Any use of Restore the Legacy’s images, videos, or other media requires explicit written consent from the foundation chair.
- Unauthorized reproduction, distribution, or modification of our media is strictly prohibited.

9. Cookies & Tracking Technologies

- Our website uses cookies to enhance user experience and collect analytics.
- You can control cookie settings through your browser.

10. Changes to This Policy

Restore the Legacy reserves the right to update this Privacy Policy at any time. The latest version will always be available on our website. Continued engagement with us constitutes acceptance of any changes.

11. Governing Law & Disputes

- This Privacy Policy is governed by Dutch and European law (GDPR).
- Any disputes shall be resolved under the appropriate Dutch legal jurisdiction.
